Waiver and Release Agreement

Knowing this, and in consideration of me or my children being permitted to participate in the Activities, I hereby release each of the Covered Entities from and against any and all liability resulting from or arising out of my or my child’s participation in the Activities. By entering into this Agreement, I am not relying on any oral or written representation or statements made by any person, other than what is set forth in this Agreement. I agree that this Agreement shall be governed by and interpreted in accordance with the laws of the State of California, U.S.A., without regard to any conflict of law principles. If any provision of this Agreement is unenforceable or invalid, the affected provision shall be severed. The remainder of this Agreement will then be construed as though the unenforceable or invalid provision had not been contained herein.
